



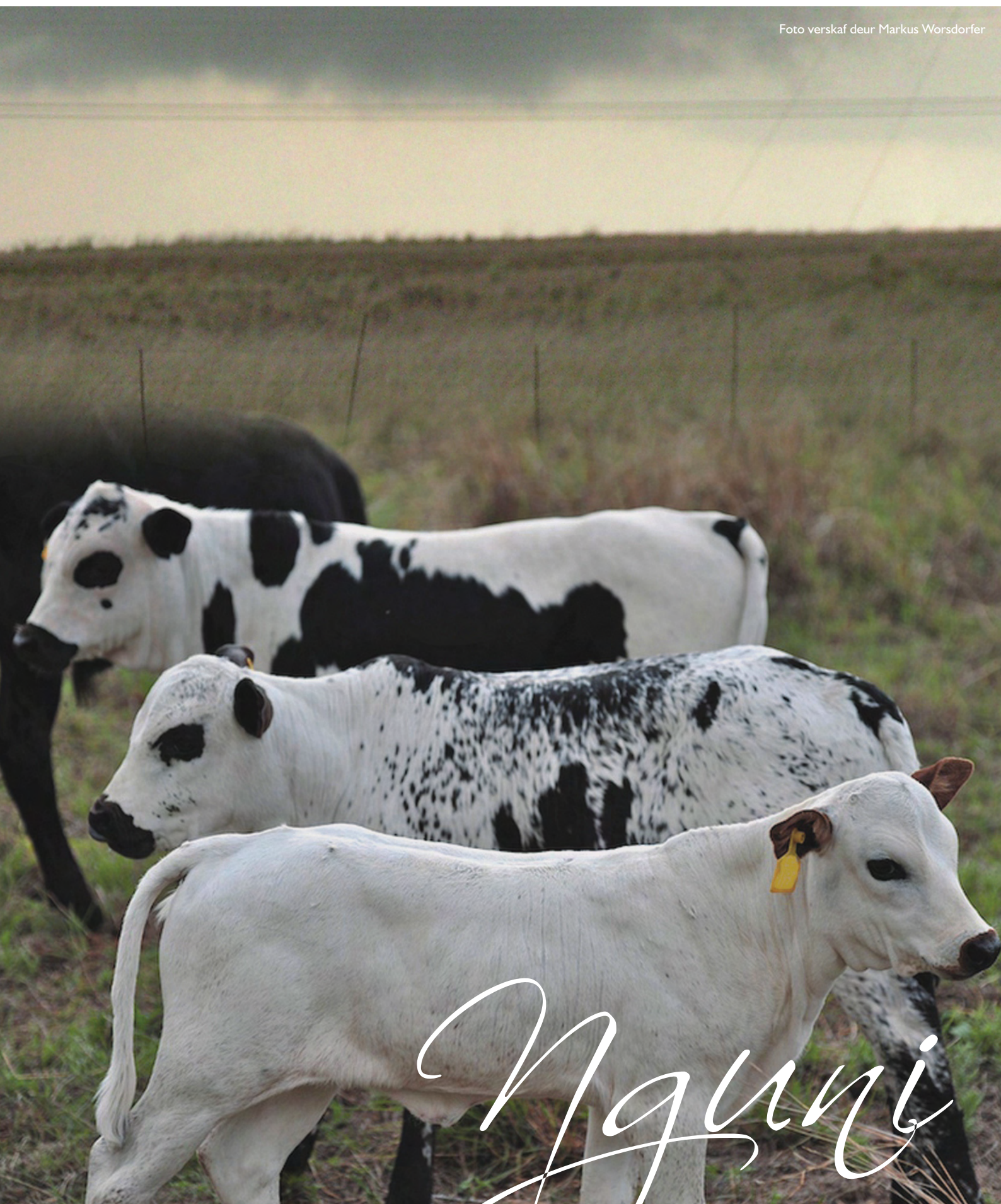

IMPORTANT COUNCIL DECISIONS

The following decisions were taken by the Council at the Council meeting held on 10 November 2011:

1. From 1 January 2012, any animal that does not meet the minimum breed standards will be cancelled automatically by the system at SA Studbook. Please make sure you send your outstanding birth notices as soon as possible to SA Studbook.
2. Annual membership fee remains the same - R1 500
3. Per capita fees for registered animals increased from R55 to R56 per animal
4. Please remember that your reinstatement fees will also be changed from R55 to R56

The following decisions were taken during the annual general meeting held on 12 November 2011:

1. That the quorum percentage should be changed from 15% to 10%. Written notice for this proposal was not given 40 days before the meeting as prescribed in the Constitution. During the meeting it was decided according to paragraph 9.2.6 that the quorum can be changed. Unfortunately according to paragraph 14.1 this could not be accepted and the percentage quorum cannot be changed. This request will be placed on the agenda for the AGM of 2012.

- 9.2.6 *No resolution shall be taken at a general meeting in respect of any matter unless notice thereof appears in the agenda sent to the members, with the notice calling the meeting, unless such a meeting agrees by two-thirds of the members present and entitled to vote that any matter not specifically on the agenda, shall be discussed and voted upon.*

14. AMENDMENTS TO THE CONSTITUTION

- 14.1 *The Constitution may be added to or altered by a resolution approved by not less than two-thirds of the members present, and entitled to vote at a general meeting of the Society, of which meeting and of which proposed addition to, alteration, variation or amendment of the Constitution, not less than 30 days' written notice has been given to each member of the Society.*

- 14.2 *No such addition to, alteration, variation or amendment of the Constitution, notwithstanding that it has been passed in the manner prescribed in Sub-clause 14.1 hereof, shall be of any force or effect until and except it is confirmed and approved by the Registrar, in terms of the Act, and shall comply with and be submitted to the Registrar in the manner as set out in the Act.*

2. Constitutional amendments

That clause 4.1.1 (d) be added as follows:

- 4.1.1 (d) *Additional members*
*Persons who are engaged, directly or indirectly, in the breeding of animals, are resident in the territory and are either the spouse, partner or child of an Ordinary Member or married to a child of an Ordinary Member, shall be eligible for membership of the Society as Additional Members who shall enjoy all the rights and privileges of membership, including the right to be elected to Council, but **excluding** the right to vote at any general meeting of the Society or to record animals under their own name.*

Consequently, that clause 4.2.1 be amended as follows:

- 4.2.1 *Application for Ordinary, Junior **[or Additional]** membership of the Society shall be made to the Secretary in writing in such a form as may be prescribed by the Council, and shall be accompanied by the relevant subscription and/or entrance fees as set out in the Society's Schedule of Fees (Schedule A).*

3. Additional Member Fee - 50% from annual membership fee

The Society received from SA Studbook the number of registered animals in your possession, as in July. SA Stud Book's annual invoicing takes place in August.

INLIGTINGSDAG VIR NUWE BEGINNER NGUNI BOERE

n Baie suksesvolle Inligtingsdag vir Nuwe Nguni Boere het op 22 November 2011 by die Thabaphaswa Bergoord in die Limpopo Provinsie plaasgevind. 135 persone het die dag se program bygewoon. Die meeste van diegene was opkomende boere asook verteenwoordigers van die Departement van Landbou.

Praktiese demonstrasies is deur Drs Piet Prinsloo en Eben du Preez gegee. Lesings is aangebied deur Cedrick Mojapelo (Raadslid), Drs Hans van der Pypekamp, Piet Prinsloo, Eben du Preez, asook Deon Richter en verteenwoordigers van Bayer.

Hierdie Inligtingsdag is versoek deur die Departement van Landbou, Limpopo en is deur Deon Richter gereël. Die Departement was verantwoordelik vir die kostes vir die verversings, middagete en lesingslokaal. Old Mutual en Bayer het ook addisionele finansiering verskaf as borge vir die dag. Hierdie was die derde soortgelyke inligtingsdag wat Deon vanjaar gereël het. Elkeen hiervan is deur 70 of meer persone bygewoon. Volgens Deon is daar 'n brandende behoefte by nuwe boere vir die regte soort inligting, terwyl sulke dae ook 'n ideale geleentheid skep om die Nguni ras te promoteer.

PRESTASIE AANTEKENINGE

Daar is 'n keuse vorm aan die lede wat prestasietoetsing doen, gestuur en die terugvoering was as volg:

- 6 (17,6%) - Nee
- 3 (8,8%) - Onseker
- 25 (73,6%) - Steun die SA Stamboek inisiatief

Van die besware is as volg: SA Stamboek opsie kan van 200% tot 300% duurder wees. Ons het na die tariewe gaan kyk wat in die briewe (wat u as prestasie aantekenaar ook ontvang het) verskyn het en 'n koste berekening gedoen soos vir 'n kudde van 200 diere.

Tans is die LNR papier opsie: R1 370.54 plus R210 (wat die Genootskap tans betaal) = R1 580.54

Elektroniese opsie: R1030.54 plus R210 (wat die Genootskap tans betaal) = R1 240.54

Dit sluit nie die aansluitingsfooie van R595.51 in nie.

Die SA Stamboek opsie sal R2206.00 per jaar wees (BLUP teelwaardes en kuddeprofiel is hierby ingesluit).

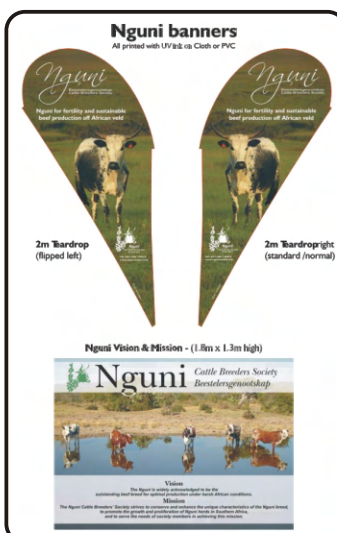
